#### What is an Officer of Election?

An Officer of Election is a person appointed by an Electoral Board to serve at a polling place for any election pursuant to Virginia Election Laws.

## What qualifies an individual to be an Officer of Election?

Each Officer of Election must be:

- a competent person, fully capable of performing all required duties in a mature, pleasant and calm manner;
- 2. of good moral character; and
- 3. a qualified voter of Viriginia to serve in Augusta County

# What disqualifies someone from becoming an Officer of Election?

An Officer of Election must not:

- 1. hold any elective office; or
- 2. be the deputy or employee of an elected official

# When are Officers of Election appointed?

The Electoral Board appoints election officials during their annual meeting held the first week of February.

#### How long is the term of office?

The term of office begins March 1 of the year appointed and continues for one, two, or three years. Officers of Election serve for all elections held in their

precincts during their term, with the exception of a primary election involving only one political party.

## Are Officers of Election party affiliated?

The Electoral Board, when appointing Officers of Election, *must* ask each officer which party he will agree to **represent**: Democrat or Republican. The officer is **not** required to be a **member** of either party.

## What are the duties of an Officer of Election?

Duties include, but are not limited to:

- Reporting to work 5:00 A.M. on Election Day
- Preparing the polling place for voting (arranging tables and chairs, posting signs, opening voting machines, etc.)
- Aiding in the verification of voter information and activating the voting machines for voters throughout the day
- Helping to close the voting precinct (certifying the number of votes cast, completing the required paperwork, packing supplies, etc.)
- Remaining at the polling place until all work is complete
- Being available to appear at the Office of Voter Registration if called by the Electoral Board on the day following the election

#### When is Election Day?

A General Election is held on the Tuesday after the first Monday in November **each** year. Primary Elections, when called, are generally held the second Tuesday in June. Primary and Special Elections are called by governing officials as required by law.

# Are Election Officers trained to perform their duties?

Yes, all Officers of Election receive training prior to the election. Each officer receives written Election Day Guidelines, which are useful in problem solving and addressing issues that may arise at the polls on Election Day.

## What occurs when an Officer of Election cannot work an election?

The Electoral Board appoints a number of Alternate Officers of Election, who are qualified and available should their services be needed. Alternates may choose to attend the training offered for Officers of Election, and understand they are deemed to be "on-call" for all elections.

# Are Officers of Election compensated?

The governing body of the county does compensate its Officers of Election for services rendered on Election Day.
