## Matters to be Presented by Staff

Ms. Whetzel provided an update on the VATI 2021 grant that is under construction by MGW/Lingo Networks. Work continues in all four project areas:

- Middlebrook: Overhead construction is completed on northern section of project area, which included 46 passings. Overhead construction started on the southern section. VDOT and/or additional SVEC permit needed.
- Morris Mill: Overhead construction on Dominion-owned poles is close to completion. Fiber-to-thehome installs continue throughout project area where mainline work is complete.
- Deerfield: A lengthy, rural spur off of Deerfield Rd (Marble Valley area) is complete. Fiber-to-thehome upgrades/installs continue throughout project area where mainline work is complete.
- McDowell: Fiber-to-the-home upgrades/installs continue throughout project area where mainline work is complete. Mainline work in the Davis Run area is complete.

DHCD will conduct an onsite assessment of the VATI2021 project on August 8, 2022.
Fifty-four percent (54\%) of the milestones have been completed to date. An extension will be requested due to weather delays, staff out with COVID, delays in easements and supply chain issues. There was a flip from overhead fiber installation to underground fiber installation in a portion of the Middlebook project area requiring a VDOT permit.

Below is a summary of work to date. Please note that milestones are set on two month increments, so therefore the passings will be updated every other month.

The mapping project did not progress as quickly as anticipated. The state has issued a Broadband Availability Map and it is hopeful that this information will assist with the Augusta County map.
