

CAMPGROUND RULES AND REGULATIONS

These rules shall apply to all persons who enter the campground for any reason and are applicable in addition to the established park-wide rules. Violations shall be cause for removal from grounds or other appropriate action, and refunds will not be given.

- No camper shall infringe or interfere upon another's right of usage or enjoyment of the park.
- All campers are responsible for registration and the payment of fees associated with camping use. Family is identified as immediate unmarried children living with parents.

Site Specific:

- Check-in time is 2:00 pm and Check-out time is 12:00 noon for all reservations.
- A person must be at least 21 years of age to reserve a campsite and occupy it without other adults present for a period of more than 8 hours.
- There is a two week/14 consecutive night limit for all RV site reservations, and a five consecutive night limit for all Tent site reservations. All households are limited to 21 nights total in a 30-day period, including those RV site reservations that utilize our camper storage program.
- 10:00 pm until 8:00 am are designated as quiet hours. All bright lights and noise levels should be reduced in consideration of other park patrons.
- Each camp site may host only one RV, trailer, pop-up, or fifth wheel camper. Up to one tent may be set up in addition to a camper/trailer. If no camper/trailer is on site, up to two tents may be set up per site.
- Please be sure you are in the site assigned. You will be asked to move if you are in the wrong site. Do not move from one campsite to another, or move picnic tables or fire rings without permission.
- All day guests must depart by 10:00 pm.
- Only two vehicles per camp site will be permitted. Please ensure that vehicles are parked within your site boundaries and do not block the campground roads.
- One picnic table and one fire ring are provided by the park on each campsite and included in the established fee. Please do not move them to another site or remove others from a site to yours without permission of park staff.

QUALITY RECREATION & LEISURE OPPORTUNITIES

General:

- Please watch for all pedestrians and yield to them.
- The dumping of raw sewage or gray water is prohibited by State code.
- The cutting of trees or any other vegetation is prohibited within the park.
- Pets must be on a leash or contained at all time. Proof of license and vaccination is required and may be requested. Please clean up after your pets.
- Fire rings are provided and all fires must be contained within them. Firewood is
 for sale from the camp hosts on site F1, or at the Visitor Center during open
 hours. Firewood brought into the campground must originate in Virginia, and
 must be burned and not left on site. Fires should never be left unattended and
 must be out before retiring for the night.
- Trash should be removed to the dumpster provided at the front of the park.
 Please place bagged trash in the dumpster or place in the proper trash containers within the campground. Please do not leave trash out overnight, and do not place trash bags on picnic tables or in fire rings.
- No person shall consume or possess an open or previously opened container containing any alcoholic beverage, or be under the influence of an alcoholic beverage while in a public park.
- All off-road vehicles such as three and four wheelers, mini bikes, or go-carts etc., are prohibited. Electric golf carts and bicycles are allowed.
 - All golf carts must be registered at the park office, and the owner must provide a copy of valid insurance
 - Only licensed drivers, 16 years and older, may operate carts
 - Carts operated after dark must have lights
 - No golf carts are to be operated after quiet hours
 - Anyone caught driving in an unsafe manner will lose cart driving privileges
- Parents are responsible for the actions and safety of their children in all areas of the campground. Children should wear safety helmets while biking.
- Campers are held responsible for any damages to campsites or any other park property.
- Please check your camping area prior to departure and report any repair that is needed to the office.
