- Too much "Red" Urban Service Areas
  - Deleted some areas on the Route 11 north corridor and around the airport; added to the Route 254 area and by Emerald Hills at property owners' request

- Too much "Yellow" Rural Conservation Areas and not enough "Green" Agriculture Conservation Areas
  - Moved approximately 27,000 acres from RCA to ACA; moved some from ACA to RCA at property owner's request
- Deleted Rural Community designation from Buffalo Gap and Stokesville
