## **CHAPTER 19. SERVICE CHARGES AND PERMIT FEES**

### **ARTICLE I. Zoning and Subdivision**

# § 19-1. Collection of fees for the review of plats and plans, inspection of facilities and other expenses.

The fees and charges imposed by this article are to cover the cost of making inspections, issuing permits, advertising of notices, conducting public hearings, reviewing plats and plans and other expenses incident to the administration of the county zoning and subdivision ordinances, amendments thereto and appeals therefrom. #### § 19-2. Subdivision plats, agreements and inspections.

The fees and charges related to the subdivision of land pursuant to chapter 21 of the Code are as follows:

## § 19-10. Fees for street signs.

The subdivider shall pay the county to erect the street signs in accordance with the county's design standards. The cost shall be as follows:

## **ARTICLE II. Buildings.**

#### § 19-11. Issuance of permit; payment of fee prerequisite.

All permits issued under the provisions of the Building Code for which the payment of a fee is required by this chapter shall be issued by the Building Official on proper forms showing the date, purpose, description, measurements and time limits, if any, and shall not be signed or approved by him until the permit fee has been received.

## § 19-12. Constructions, additions and remodeling.

The fee for a building permit shall be in accordance with the following schedule:

- A. Residential new construction and additions: 18¢ per square foot of heated, finished living space, \$75 minimum.
- B. Residential accessory structures: 18¢ per square foot with a \$75 minimum charge.
- C. Residential swimming pools, hot tubs and spas: \$75 each.
- D. New commercial construction, including additions, but not including stadiums and other uses in Use Group A-5, by square feet in gross floor area, based on an election made by the applicant at the time of application for a building permit of one of the following permits:
  - (1) a permit for each unit of the structure at the rate of 18¢ per square foot of the unit for the first 5,000 square feet, and 10¢ per square foot for each additional square foot of the unit, with a \$100 minimum charge;
  - (2) a permit for the entire structure at the rate of 18¢ per square foot for the first 5,000 square feet of the structure, and 10¢ per square foot for each additional square foot of the structure, with a \$100 minimum charge; or
  - (3) a permit for the building shell at the rate of 9¢ per square foot for the building shell and, after completion of construction of the building shell, a permit for interior build-out within the shell at the rate of 9¢ per square foot (for a total fee of fifteen cents (18¢), with a \$100 minimum charge.
- E. New commercial construction, including stadiums and other uses in Use Group A-5, and including additions thereto, by square feet in gross floor area (\$100 minimum charge):

	first 20,000 square feet: additional square feet:	2¢ per sq. ft. 1¢ per sq. ft.
F.	Commercial swimming pools:	\$75.00
G.	Elevators, escalators, lifts:	\$100 each

H. Alterations and repairs:

Residential: 18¢ per square foot with a \$75 minimum charge. Commercial: 18¢ per square foot for the first 5,000 square feet, and 10¢ per square foot for each additional square foot, with a \$100 minimum charge.

- I. Antennae and towers: \$100
- J. Temporary certificates of occupancy and extensions will be issued for forty-five (45) days upon payment of the following fees:
  - (1) Residential per dwelling unit \$50 for the initial 45-day period, increasing by \$50 for each subsequent 45-day period, but in no event to exceed \$200 for a 45-day period; and
  - (2) Nonresidential \$100 for the initial 45-day period, increasing by \$100 for each subsequent 45-day period, but in no event to exceed \$400 for a 45-day period.
- K. The fee for an amendment of a building permit to add the name of or amend the name of a mechanic's lien agent shall be \$50.

#### § 19-13. Relocating structures.

A building permit shall not be required for the moving of any building twelve (12) feet wide or less and which is not connected to public utilities or will not be connected to public utilities at its new location. In all other cases, a building permit shall be required and the fee shall be 0.18 per square foot of heated space. (Ord. 9/23/15; 7/28/21)

#### § 19-14. Demolition.

No fee shall be required for buildings which do not require a permit to construct per the Uniform Statewide Building Code. In all other cases, a building permit shall be required and the fee shall be seventy-five dollars (\$75.00) for each building to be demolished. (Ord. 9/23/15)

#### § 19-15. Signs.

A building permit shall not be required for the erection of any sign that is exempt from the Uniform Statewide Building Code. In all other cases, a building permit shall be required and the fee shall be one hundred dollars (100.00). Multiple signs on the same property can be covered on the same permit. (Ord. 9/23/15; 7/28/21)

#### § 19-16. Manufactured home permits.

Permits shall be required for the placement of structures defined as manufactured homes by the Code of Virginia. The fee shall be one hundred fifty dollars (\$150.00). Similar structures not meeting said definition shall be subject to the fees applicable to other structures. Electric and plumbing permits will also be required for connection of the home to required utilities. (Ord. 6/13/07, eff. 7/1/07; 7/28/21)

## § 19-17. Amusement device permits.

Permits shall be required for each set-up in the county as follows:

A. <u>Rides</u>. The following charges are imposed to permit the set-up of the following amusement rides:

Small Mechanical Ride or Inflatable	\$25 each
Circular or Flat Ride	\$35 each
Spectacular rides	\$55 each
Other amusement devices	\$25 each

B. <u>Outside qualified inspections</u>. The fee for amusement devices when inspections are performed by an outside qualified inspector shall be 50% of the fees listed in Paragraph A above.

#### § 19-18. Plumbing permits.

Fees for plumbing installations, additions and alterations shall be in accordance with the following schedule:

Residential alterations and repairs	\$75 each
Commercial alterations and repairs	\$5 per fixture/\$75 min

## § 19-21. Levies by the Board of Housing and Community Development.

In addition to other fees as may be imposed by law, the county building department shall collect such levies as may be imposed by the Virginia Board of Housing and Community Development and transmit such levies to the Department of Housing and Community Development as required by law.

## § 19-22. Refunds.

Upon withdrawal or cancellation of an application for a permit for which a fee has been paid pursuant to this article, the Building Official may, within his sole discretion, reimburse up to 75% of the fee paid. (Ord. 5/25/94)

#### § 19-23. Miscellaneous inspection fees.
